Date: 07-25-21 (Sunday)

21-3523 0745 EDP N 2nd St.

A caller reported her neighbor breaks into her apartment with a shaved key, listens to her through the walls and is stealing people's stimulus money from the government. An officer determined this was a mental health issue and not criminal.

21-3524 0907 EDP Pine St.

A caller reported a male at this location was claiming to be Jesus/God. An officer responded and spoke with the male, who said he did not identify as anyone. He agreed to leave the property after he was told not to drive due to having a suspended license.
