GENERAL BUILDING DATA

The owner/contractor shall verify all dimensions and site conditions before starting work. The owner/contractor shall notify the Building Codes Division of any discrepancies, changes, omissions, or substitutions that are not permitted without the approval of the Building Department having jurisdiction. All workmanship shall conform to Oregon Residential Specialty Code.

All wood in contact with the ground, embedded in concrete in direct contact with the ground or embedded in concrete exposed to the weather that supports permanent structures shall be approved pressure preservative treated wood suitable for ground contact use.

In geographical areas where experience has demonstrated a specific need, approved naturally durable or pressure preservative treated wood shall be used for those portions of wood members that form the structural support of decks, porches, balconies or similar permanent building appurtenances when those members are exposed to the weather without adequate protection from a roof, such members may include:

- 1. Horizontal members suchs as girders, joists, and decking.
- 2. Vertical members such as posts, poles and columns.
- 3. Both horizontal and vertical members

Diagonal bracing required beam to column on each end front of deck with one 1/2" bolt each end of brace

Guards shall be located along open-sided walking surfaces, including stairs, ramps, landings, and decks that are located more than 30" measured vertically to the floor or grade below at any point within 36" horizontally to the edge of the open side.

Required guards at open sided walking surfaces, include stairs, porches, balconies, landings, or decks, shall not be less than 36" high measured vertically above the adjacent walking surface.


Exceptions:


- 1. Guards on open sides of stairs shall have a height not less than 34" measured vertically from the line connecting the leading edges of the treads.
- 2. Where the top of the guard also serves as a handrail on the open sides of stairs, the top of the guard shall not be less than 34" and not more than 38" measured vertically from a line connecting the leading edges of the treads.


Required guards shall not have openings from the walking surface to the required guard height which will allow passage of a sphere 4" in diameter.

Exceptions:

- 1. The triangular openings at the open side of a stair, formed by the riser, tread and bottom rail of a guard, shall not allow passage of a sphere 6" in diameter.
- 2. Guards on the open sides of stairs shall not have openings which allow passage of a sphere 5" in diameter



- Maximum differential between treads and risers shall not exceed 3/8"
- 5. Open risers are permitted if opening does not exceed 4" height 6. Minimum nosing 3/4" to maximum 1-1/4"

HANDRAIL NOTES:

- 1. Handrails shall be continuous on at least one side with four risers or more
- 2. Top of handrails shall be between 34" min. to 38" max above stair nosings
- 3. Handrails shall be between 1-1/4" to 2-1/4" gripple surface
- 4. Handrails shall be placed not less than 1-1/2" clear from wall 5. Handrails shall return to wall, post, stairway
